**TERMS & CONDITIONS****General Conditions**

\*Minimum rental is 1 day. The 25<sup>th</sup> hour is free of charge. An extra day will be charged from the 26<sup>th</sup> hour.  
\*The vehicle will be provided with a full tank of fuel and must be refilled prior to car return (only with unleaded gasoline), otherwise a charge of 1,75 € per litre\* of gasoline in addition to a refueling fee of 10,00 € + VAT (23%) will apply - indicative cost. (depends on the valid average fuel cost)  
\*All traffic fines resulting from violation of the Greek Traffic law are borne by the renter (the renter will be charged).  
\*All vehicles are insured: a) against liability to third parties (excluding driver) for death and injury up to 750.000,00 € per victim b) material damages to third parties (excluding the vehicle) up to 750.000,00 €) for fire of the vehicle. If the Vehicle is damaged or stolen by driver's culpability or negligence, the driver will be presided for, up to the total cars' commercial value at the time of accident or theft.  
\*CDW insurance: The driver limits his responsibility to any damage of the vehicle to the amount as mentioned in the above column "Excess", provided that the traffic laws where not contravened.  
\*None of the insurance cover damages caused by infringement of the traffic law, as well as damages to tires, mirrors, windscreens, car parts underneath the vehicle and in the cabin.  
\*Incident Administration Fee: In case of an accident due to the renter's liability, renter has the obligation to pay a non refundable fee of 15,00 € + VAT (23%) in order to cover administration expenses.  
\*Administration Fee for fines: The driver is liable for the payment of all traffic fines that may occur during the car rental. In case the driver does not pay the fine(s), there will be an Administration Fee for the final of 20,00 € + VAT (23%) additional to the fine's cost.  
\*Loss or damage of key: In case of loss or damage of the car key during the rental, the driver is liable for following charges: a) 60,00 € + VAT (23%) for car groups MCMR, EDMR, CCMR b) 100,00 € + VAT (23%) for car groups CDMR, IDMR, SDMR, CDAR, SDAR, CWMR, SVMR, CFMN, ITMR c) 20,00 € + VAT (23%) for car groups FVMR, PDMR, XDMR, FFMR.  
\*Car cabin: In case the driver returns the vehicle and it's cabin has stains which require a special cleaning procedure (i.e. animal hair, sand etc on car floor or port baggage), he will have to pay 80,00 € + VAT (23%)  
\*Delivery and collection is free to any station in the center or at the airport in the same city or in stations of the same island (except for South Crete and South Corfu).  
\*\*"Rent it here-Leave it There" Service (at/from check points as stated below: it is applicable for at least 5 days minimum rental period between Athens-Kinetta-Thessaloniki-Chalkidiki-Kavala-Alexandroupoli-Volos-Patra and in Crete between Heraklion-Chania-Rethymno-Ag. Nikolaos, after having in advance our written authorization. To all other destinations and for 1-4 days rental period, please contact us to inform you about the extra charge.  
\*Driver must be 23+ years old for groups MCMR, EDMR, CCMR, CDMR and 25+ years old for all other groups and have a personal credit card used as deposit.  
\*Drivers aged between 21-22 will be subject to Young Drivers Surcharge by paying the amount of 20,00 € plus VAT (23%) daily.  
\*Ferrying the vehicle: Not allowed.  
\*Across the border rental: not allowed.  
\* In case VAT increase, rates will be increased accordingly  
\*Rates and Conditions may change without notice.

**Payment and cancellation policy**

In order to confirm any reservation, full **payment in advance is required, fully refundable for any cancellation received at least 16 days prior** the 1<sup>st</sup> day of rental.  
In case of any cancellation received in written within 15 days prior the 1<sup>st</sup> day of rental of the vehicle, **10,00 € cancellation fee** will be charged (per vehicle). In case of any cancellation received same day of the 1<sup>st</sup> day of rental and/or non shows, the reservation will automatically be cancelled and cancellation fees of **1 day rental cost will be charged** (per vehicle). Charges according to the requested type of car. Refunds will be effected within 1 month after Posidonia 2012 (credit card or bank charges will be deducted).
